Executive Summary

On behalf of the County of Oneida, I am pleased to present the Livable Communities of Oneida County Progress Report for 2019 through 2024.

Oneida County recognizes the importance of promoting age-friendly planning and policies to address changing demographics and enhance independent living. In 2016, our County applied for membership to the AARP Network of Age-Friendly communities, an independent affiliate of the World Health Organization Network of Age-Friendly Cities and Communities. In 2019, we completed a needs assessment process that included a comprehensive community survey and hosting focus groups throughout the County.

In 2021, the Livable Communities of Oneida County Action Plan was completed with the input of leaders from diverse communities, government bodies, and organizations serving residents from across the County. This Progress Report reflects the Action Plan's two years of assessment and development followed by three years of implementation. It highlights our age-friendly work across eight domains of livability: civic engagement; social participation; outdoor spaces and public buildings; health and community services; housing; transportation; communication and information; and respect and inclusion.

Livable Communities of Oneida County will continue as a collaboration between its three lead partners (The County of Oneida, The Community Foundation of Herkimer & Oneida Counties, and 50 Forward Mohawk Valley) working with many community partners to grow this important age-friendly initiative. The next step will be to develop a new threeyear action plan, which will further develop many of the programs and projects already in place as well as add new goals in response to what we have learned over the past five years.



Oneida County, NY

Oneida County is situated in the beautiful Mohawk Valley of Central New York. The county is a diverse urban-rural mixture comprised of three cities, 26 towns, and 16 villages. In 2019, the two largest cities of Utica and Rome had a combined population of approximately 96,000, or nearly 42% of the county's total population. In 2020, Oneida County's population was 232,125, and an estimated 20.3% of residents were over 65 years old in 2023 (United States Census Bureau).



Vision

We believe that communities should provide safe, walkable streets; age-friendly housing and transportation options; access to needed services; and opportunities for residents of all ages and abilities to participate in community life.

Project Development

In 2016, 50 Forward Mohawk Valley (formerly the Parkway Center); Oneida County Office for Aging and Continuing Care; Oneida County Department of Planning; and the Community Foundation of Herkimer & Oneida Counties came together to discuss the AARP Age-Friendly Community initiative and the possibility that Oneida County could become an Age-Friendly Community.

On July 26, 2016, Oneida County Executive Anthony J. Picente, Jr., submitted an application to AARP for membership in the AARP Network of Age-Friendly States and Communities, which was approved on November 18, 2016. Steering Committee members committed to guiding this project and included representatives from the County Departments of Health, Planning, Mental Health, and Office for Aging and Continuing Care as well as representatives from The Community Foundation of Herkimer & Oneida Counties and 50 Forward Mohawk Valley.

Steering Committee members made specific commitments to ensure the initiative's forward momentum. Oneida County committed to providing resources of staff, printing, data entry and support. In 2017, the Community Foundation of Herkimer & Oneida Counties committed to dedicating staff time to the initiative and supporting a two-year project coordinator position, which they continued to renew. 50 Forward Mohawk Valley committed dedicated staff time, resources, and supervision of the Project Coordinator.

Age-Friendly Process

The **Getting Started Phase** began with establishing eight Work Groups to address the eight domains of livability as listed in the AARP guidelines and as outlined by World Health Organization (WHO). Each Work Group was assigned co-chairs from the Steering Committee along with a community leader with a background in, or connection with, the work group's topic.

Representatives from non-profit organizations and businesses as well as community members were invited to serve on the Work Groups. Each Work Group was given the AARP guidelines for their specific domain to begin the discussions. Work Groups were asked to outline positives and weaknesses of the County in their assigned domain, to review Oneida County's "livability score" given by AARP for each area of livability, and to prepare for the next phase: Needs Assessment and Planning.



Oneida County is committed to improving and supporting active and healthy aging for our residents.

Assessment

The **Needs Assessment Phase** was completed in a two-part process: a Community Survey and Focus Groups. The Steering Committee assumed the role of developing a community survey based on the AARP Needs Assessment Survey. The survey was disseminated throughout the entire County in both rural and urban areas. The Project Coordinator held many outreach events at senior centers, local libraries, local eating establishments, senior meetings, community partner events, and health fairs, and tabled at the shopping mall. Utica University Occupational Therapy graduate students assisted in many events. Surveys were collected both on-line and via paper copies. Over 1,700 surveys were completed.



Survey

The Oneida County Planning Department provided staffing resources to analyze the data from the surveys and map the County to ensure surveys represented the entire County.

Focus Groups

A strong partnership was developed with the Utica University Occupational Therapy Program, specifically for conducting, gathering, and analyzing the data from nine focus groups.

Findings

The Community Assessment was completed in 2019. Data gathered through the survey and focus group processes were shared as full reports in the appendix of the final Action Plan.

Action, Evaluation, and Implementation

Action and Evaluation Plan Phase

The Work Groups used the Community Assessment findings to develop Work Plans for their respective livability domains. Each Work Plan contained main action items, goals, specific action items, who would be involved, a facilitator, date for completion, and performance indicators for evaluation purposes. The Work Plans were compiled into the comprehensive 2021 Action Plan.

Implementation Phase

The Steering Committee supported the Work Groups during the phase of Implementation and continued developing the County's Action Plan as a road map for age-friendly initiatives.

Our age-friendly process is designed as a cycle of continuous evaluation and improvement.



Domain 1: Civic Engagement

Our Vision for Oneida County: To expand opportunities for persons of all ages to engage in meaningful paid employment and volunteer positions free from age discrimination. We will improve the level of participation for people of all ages and abilities.



Volunteer Resource Center

In partnership with Oneida County Office for Aging and Continuing Care, 50 Forward MV created a Volunteer Resource Center to connect volunteers of all ages to services for seniors, such as a snowshoveling program and intergenerational projects.



Job training for older adults

10 Oneida County older adults participated in the Associates for Training and Development (A4TD) program to develop employment skills in 2024.



Self-employment resources

An age-friendly flyer was developed with Mohawk Valley Small Business Development Center to promote self-employment resources available for Oneida County older adult residents.


Domain 2: Social Participation

Community activities

Working with Oneida County Tourism and Sentinel Media Company, an age-friendly flyer was developed to promote print-based resources that are available to help older residents become aware of activities and cultural events.



Welcoming neighbors

In partnership with The Center, 50 Forward MV has begun offering programs for non-English speaking residents, English-learners, and refugee residents of West Utica.



Senior Theater volunteers

Volunteer-based programs like Senior Theater provide opportunities to socialize and meet new people as well as to share volunteers' artistry with older adults in assisted living communities and nursing homes through on-site performances.

Domain 3: Outdoor Spaces & Public Buildings

Age-friendly zoning

Oneida County Department of Planning will provide sample zoning laws to municipalities upon request that encourage and permit a variety of housing types and accessory dwelling units as well as pedestrian-friendly requirements that connect to community services or public transportation.



Roscoe Conkling Park

The City of Utica created a new dual-purpose ice rink and pickleball court at the Roscoe Conkling Park, which included new lighting, seating, and landscaping.



City of Rome pop-up project

In 2022, Livable Communities and the City of Rome partnered to implement a temporary installation for testing potential improvements to the Griffo Green around City Hall, with the goal of enhancing year-round programming and special events. The project remained in place all summer for community members to provide feedback.

Evidence-based programs

50 Forward Mohawk Valley offers eight evidencebased health and wellness preventive programs to sites throughout the county: A Matter of Balance, Aging Mastery Program, Balance & Mobility Progression, Enhance Fitness, Health Literacy, Stay Young Strong Bones, Walk with Ease, and Rock Steady Boxing.



15 units of housing for homeless and frail older adults were established at the Jason Gwilt Memorial Apartments, with support funding from Empire State Supportive Housing Initiative (ESSHI).

A Mobility Specialist was hired to educate, update, and advocate for Oneida County residents on transportation resources and options.



Way2Go

In partnership with the Oneida County Office for Aging and Continuing Care, 50 Forward MV provides non-emergency medical transportation to Oneida County residents using volunteer drivers.



Trail guide

The Herkimer-Oneida Counties Transportation Council developed a comprehensive bicycle and pedestrian trail guide for Oneida County.

AgeNet communications

AgeNet digital information system was established by Oneida County Office for Aging and Continuing Care and 50 Forward MV. It was installed at participating senior centers to share information about community events and social opportunities.



Technology center

50 Forward West Side tech center opened to provide internet access and education on technology use for older adults.



Website and Facebook

The Livable Communities website and Facebook page were launched to share information about the initiative with partners and residents and to promote age-friendly planning and policies throughout the County.

Intergenerational activities

Intergenerational programs are offered through Utica University's Young Scholars Liberty Partnerships Program (YSLPP) and STEPS program.



Older adult voices heard

Oneida County Office for Aging and Continuing Care held annual public forums to engage older adult residents in public policy and practice and to gather perceptions of respect given to older adults in the community.



Ageism awareness

Phase one of an ageism awareness campaign was implemented through sharing social media posts on Ageism Awareness Day along with a downloadable fact sheet link from the American Society on Aging.
